We support partnerships on:

- 10. Smart Networks and Services (water should be included though)
- 31. A climate neutral, sustainable and productive Blue Economy
- 32. Safe and Sustainable Food System for People, Planet & Climate
- 33. Circular bio-based Europe: Sustainable, inclusive and circular bio-based solutions
- 34. Water4All: Water security for the planet

However, we regret that no partnership on health is focused on impact of drugs on the environment as the strategic approach on Pharmaceuticals in the Environment of the European Commission (https://www.ec.europa.eu/environment/water/waterdangersub/pdf/strategic\_approach\_pharmaceuticals\_env.PDF) promote a chain approach with "green design" of "products that pose a lower environmental risk or facilitate the recycling of waste water, and promote the use of greener manufacturing methods".
