Overflows from sewers or wastewater treatment plants and urban stormwater overflows are considered to be a land-based source of marine litter. However, wastewater services are just a pathway to the marine environment. The issue is largely covered by UWWTD, setting standards for the treatment of sewage discharges from coastal and estuarine areas, hence preventing larger items of sanitary waste to be spilled into the marine environment. The particulate plastics are an emerging source of pollution, and good knowledge on the role of the wastewater is lacking and more monitoring and research are needed. Targets on marine litter can contribute to involve all stakeholders and help politicians to identify possible solutions with greater priority. Rather than putting targets for reduction of Marine litter, original sources of marine litter and potential source control actions should be identified. Impacts of marine litter and potential cost/benefits of control measures should be studied.
